SECTION 4: FIRST AID MEASURES

4.1. Description of first aid measures

Inhalation: Move into fresh air and keep at rest. In case of persistent throat irritation or coughing: Seek medical attention and bring these instructions.

Skin contact: Remove contaminated clothing. Rinse skin immediately. Thoroughly rub with liquid soap and wash with lukewarm water. Get medical attention if any discomfort continues.

7.1. Precautions for safe handling

Safe handling advice: Observe good chemical hygiene practices. Avoid inhalation of oil mist and contact with skin and eyes. Avoid prolonged and repeated contact with oil, particularly used oil. Wash hands before breaks and before smoking, eating or drinking.
